# Saitama Prefecture Certified Care Worker Study Loan Guide 2019



We lend money for tuition fees and other expenses for students who aim to become certified care workers and are enrolled at one of our designated care worker training facilities with no interest.

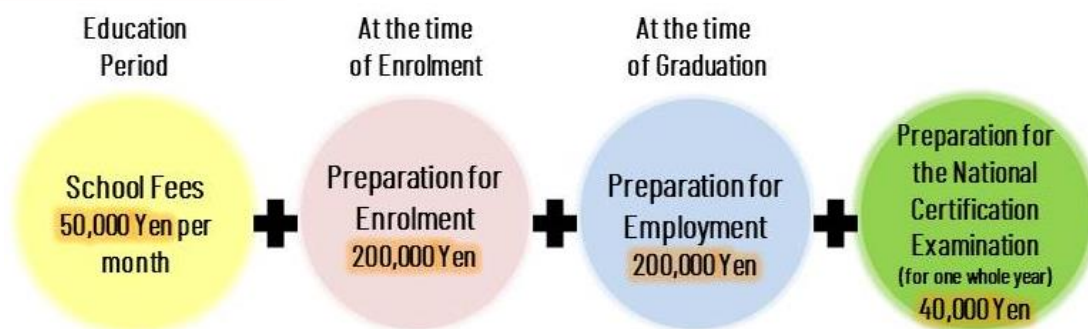
After graduating from a designated care worker training facility, certified care workers who work at a social welfare facility in Saitama Prefecture for five (5) years will be exempted from paying off the loan.

## ◆ Targeted Consumers ◆

Students who are currently enrolled in the designated care worker training facilities in Saitama Prefecture and wish to work in social welfare facilities in Saitama Prefecture as certified care workers in the future.

## ◆ Loan Amount and Loan Period ◆

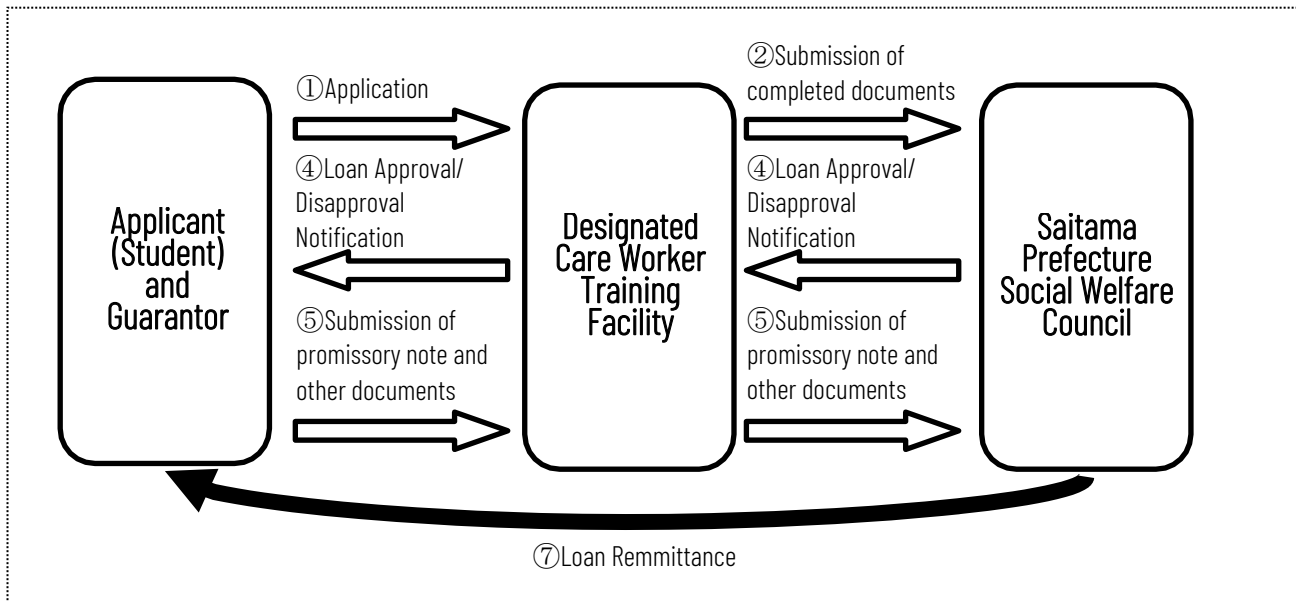

## ◆ Repayment Exemption ◆

The repayment of fund will be waived if the following conditions are met: the certified care worker graduated from a designated care worker training school, registered as a certified care worker within one year, employed at a social welfare facility within the prefecture, and engaged in caregiving work for five years straight. The application for repayment exemption is held annually, submission of "Work Engagement Report" and other documents are necessary.

## ◆ Application Process ◆

Please submit the documents to the school you are currently enrolled in. The school must be a designated care worker training facility.

✂The period of acceptance of documents, person in charge, and process vary depending on the designated care worker training facility. Please confirm with your school's student center or employment department.

## ◆ Important Points ◆

- Application documents must be submitted through a designated care worker training facility. If you are interested, please coordinate with your school's student center.
- There is a loan inspection. Loan approval or disapproval depends on the result of the inspection.
- If you withdraw from school or were not able to complete the five-year certified care worker job, you will be asked to return the money lent to you as well as cancellation of loan contract.
- If the applicant is a minor, the guarantor must be a legal representative (guardian). Furthermore, the guarantor is also responsible for the repayment of loan.
